## RESEARCH ETHICS BOARDS

### BOARD MEMBERS NEEDED — KNOWLEDGEABLE IN THE LAW

Are you interested in a volunteer opportunity? Dalhousie University's Research Ethics Boards are accepting expressions of interest for members knowledgeable in the law. The role of the member knowledgeable in the law is to alert the research ethics boards to legal issues and their implications (e.g., privacy issues), not to provide formal legal opinions or serve as legal counsel for the board.

### WHAT IS THE RESEARCH ETHICS BOARD?

The mandate of the boards is to review the ethical acceptability of research involving humans conducted by university faculty and students. Dalhousie University has two research ethics boards: health sciences and social sciences & humanities. Both consist of faculty members with expertise in the relevant research disciplines and methodologies, community members with no affiliation with the university, and members knowledgeable in ethics and in the law.

### WHAT WILL I BE ASKED TO DO?

Every month, you will read research projects (usually 2–3) from faculty and student researchers, making notes about any ethical concerns. You will attend monthly meetings at which you will share your review and contribute to the ethical deliberations of the board.

### WHAT IS THE TIME COMMITMENT?

The time commitment is normally 4–6 hours in the first half of each month. The monthly meeting can take up to 3 hours; preparing for the meeting takes another 1–3 hours in the 10 days before the scheduled meeting. The meeting times are scheduled up to a year in advance

and the meeting dates and times are firm. However, the preparatory work can be completed at your convenience in the 10 days prior to the meeting.

Normally, board members are appointed to serve 3-year terms.

### WHAT ARE THE MEETING TIMES?

Monthly meeting times are either:

- Friday afternoons (12:30–3:30 p.m.) (health sciences)
- Wednesday mornings (9–11:30 a.m.) (social sciences & humanities)

There are no meetings in August.

### WHAT QUALIFICATIONS DO I NEED?

- You must have a Bachelor of Laws degree
- You must be knowledgeable in the law relevant to research ethics review deliberations (e.g., privacy issues)
- You must be willing to become knowledgeable about research ethics standards and to apply them to the ethical review of research projects
- You must **not** be currently affiliated with Dalhousie University (alumna or alumnus is acceptable)
- You must be willing to contribute collegially at meetings
- You must have access to a computer and the internet and be able to read and communicate through online platforms in English
